3. Purpose and Mission of IRG

Walking is a vital transport mode and plays an indispensable role in a sustainable society. Development of attractive and functional public space consistent with natural tendencies of the community requires an understanding of relevant attributes of the local culture and the range of applicable planning concepts. This IRG is ambitious in its aim to attempt to supplement the research and planning community with guidelines specific to different East Asian cities to improve socio-cultural acceptance of urban change.

The IRG is formed to collaborate and provide leadership where necessary with researchers in this field in member countries to analyze and disseminate the cultural significance of natural pedestrian behavior with the view of developing meaningful planning guidelines. The inclusion of unique features of the heritage is important to ensure the long term sustainability and efficiency of urban developments.

Specific outcomes planned were:

- (a) the development of the research personal network,
- (b) holding a dedicated session in EASTS conferences, and
- (c) development of a planning philosophy that is sympathetic to inclusion of cultural attributes.

Abstract: The IRG-05 of the EASTS has organized a seminar on the theme of 'Theory

and Application of Pedestrian Culture' at the Department of Transport in

Vientiane, Lao Peoples Democratic Republic on Friday, Tuesday, April 10, 2012 to report and discuss recent findings of the international collaborative research team. The one day seminar provided an overview of the pedestrian travel culture research framework and focus on the impact of gender, stage of life and life style on pedestrian attitudes. The seminar was scheduled to provide separate country presentations covering findings from surveys conducted in different cities in Japan, Taiwan and South Korea. Methodological aspects and results from comparison of the pedestrian culture among different countries ware also presented. More than thirty researchers, students, and practitioners attended the seminar.

3) Group meeting:

Meeting 1:

Date: 27, December, 2012

Venue: University of New South Wales, Sydney

Abstract: A group meeting was held with Professor Tsukaguchi, Dr Vandebona and Mr Hsia and Tajima in attendance. Arrangements for the seminar scheduled in April in Lao were the focus of discussions. The meeting was able to clarify contributions suitable from different participants for the proposed seminar.

Meeting 2:

Date: 11 April 2012

Venue: Ministry of Transport, Vientiane Lao PDR

Abstract: A group meeting was held with Dr. Vandebona, Professor Tsukaguchi, Mr. Hsia and Mr Tajima and Mr Somunk in attendance. Future view of the IRG was the main point of discussion. Revisions required for the proposed monograph was discussed. There was also an interest in pursuing other publication avenues to disseminate the research work. Group also discussed potential authors for the proposed special session at the 2013 EASTS conference.

Meeting 3:

Venue: National Cheng Kung University, Tainan, Taiwan

Abstract: A group meeting was held between Professor Tsukaguchi and Mr. Hsia to discuss two publications related for the EASTS conference in 2013 related to this IRG. Structure and content of the papers were the main points discussed.

Meeting 4:

Date: Friday 07 and Tuesday 11 September 2012

Venue: University of New South Wales, Sydney, Australia

Abstract: A meeting was held between Professor Tsukaguchi and Dr. Vandebona to discuss range of topics including annual report, proposed monograph, journal papers and future directions. The previous opinion to close the IRG following EASTS 2013 conference and the completion of the Monograph was confirmed. However, this team also foreshadows the intention to apply for the formation of a new IRG again with the focus on a different aspect related to non-motorized transport and public transport users.

Four funding sources have contributed to this IRG since inception:

(a) Received a research grant (2008-2010) for pedestrian research lead by the Professor

- Yeh at National Cheng Kung University that allows team members from Taiwan, Japan, South Korea and Australia to actively collaborate. Part of the funding provided opportunity for the IRG seminar held in 2008. Program details of that seminar were presented in a previous activity report.
- (b) Received ICRA-B research grant 2009 for the value of JPY 500,000 for preparation of an International Seminar on Pedestrian Travel Culture and its Application to Pedestrian Planning. Planned at Busan National University.
- (c) Grant-in-Aid for Scientific Research of JSPS, Japan (2011-2013): Application was successful for the research on pedestrian travel culture. The representative is Professor Tsukaguchi.
- (d) Received ICRA-B research grant in 2011 for the value of JPY 500,000 for delivery of an International Seminar on Pedestrian Travel Culture planned at Vientiane Lao PDR. Program details of the seminar held were presented in the previous section.

- (b) Seminars: Three IRG seminars have been held since inception of this group. The first IRG seminar was held in December 2008 in Tainan attended by young researchers, academics from number of Universities and local government officials. The second IRG seminar subsidized by ICRA-B was held in December 2010 in Busan, Korea. Speakers came from Japan, Taiwan and Australia.

The third IRG seminar subsidized by ICRA-B was held in December 2012 in Vientiane, Lao PDR. Speakers came from Thailand, Lao, Japan, Taiwan and Australia. Attendees were undergraduate students as well as engineers and planners from government and private sector.

The IRG members encouraged students in their laboratories to consider research work directed toward pedestrian travel culture. From the second half of 2011 to April 2012, two graduate students (Hao-Ching Hsia from Taiwan and Yoshiyuki Tajima from Japan) undertook an exchange facility to conduct research at UNSW, Australia, in order to obtain a different perspective of the pedestrian travel culture with guidance from Dr Upali Vandebona. These student exchanges have been possible with funding sources from Taiwan (National Cheng Kung University) and Japan (Ritsumeikan University) respectively. Group members consider such exchange activities as an incentive for young researchers in addition to the educational value of broadening their experience and research credentials.

The IRG seminar held in April 2012 in Vientiane was well attended by undergraduate students in the planning field from National University of Lao.
