3. Purpose and Mission of IRG:

(1) Purpose

Amid the increasingly fierce competition among airports to become domestic and international hub airports, the use of transit transportation via the hub airports in each region is increasing not only in international air cargo transportation between continents but also within the Asian region. In view of this situation, this survey aims to determine the status of transit use in international air cargo transportation and, by analyzing these data, to clarify the current situation of competition at the main airports in the East Asian region. Based on the results of this survey, key tasks and development strategies will be studied in order to promote development on the basis of competition and cooperation, taking advantage of the distinctive characteristics of each main airport in East Asia.

(2) Mission

- Build database on intra-Asia and inter-continental international air transit cargo flow
- Make clear about competition relations and competition factors
- Suggest policy that how to collaborate and compete among Asian hub airports
- Use as a basic data for next long-range planning of aviation policy
